The Lifesaving Society is a full-service provider of programs, products and services designed to prevent drowning. We save lives and prevent water-related injury through our training programs, Water Smart® public education, drowning research, aquatic safety management and lifesaving sport.

We are a national volunteer organization and registered charity composed of ten provincial/territorial branches, tens of thousands of individual members, and over 4,000 affiliated swimming pools, waterfronts, schools and clubs.

The Lifesaving Society is a leader and partner in the delivery of water safety education throughout Canada and around the world. (The Society operates globally in over 25 countries.) We represent Canada in the Commonwealth Royal Life Saving Society and we are Canada's Full Member in the International Life Saving Federation. The Lifesaving Society takes lead responsibility for drowning prevention in Canada.

We have been teaching swimming, water safety and water rescue in Canada since 1896.

# Teaching Canadians to save themselves and rescue others

Annually, over 1.2 million Canadians participate in our swimming, lifesaving, lifeguard, first aid and leadership programs. As Canada's lifeguarding experts, we set the standard for lifeguard training and certify Canada's National Lifeguards.

## **Making Canadians Water Smart**

The Society focuses its public education efforts on people most at risk or on those who can make a significant difference. Our Swim to Survive® program provides the skills to survive an unexpected fall into deep water.

## **Drowning research**

The Society conducts research into drowning, aquatic injury and rescue interventions to support the Society's training programs and drowning prevention education.

#### Setting the standard

The Society establishes aquatic safety standards and consults on aquatic safety issues for the aquatic industry, governments and the judiciary.

#### Lifesaving sport

The Society is the Canadian governing body for lifesaving sport — a sport recognized by the International Olympic Committee and the Commonwealth Games Federation. Our Lifesaving Sport Fundamentals program offers a recreational introduction to lifesaving sport skills. Age-group, senior and masters athletes compete provincially, nationally and internationally.

# PRESIDENT'S **REPORT**

The year 2024 offered the Lifesaving Society New Brunswick something we haven't seen in a while: a chance to catch our breath and focus on steady progress. No sudden staff changes, no emergency pivots—just time and space for our dedicated staff and volunteers to quietly get on with the important work of building a Canada free from drowning.

But don't confuse stability with standing still. Beneath the surface, meaningful new projects took shape.

Our New Brunswick Program Guide underwent a complete overhaul—rebuilt as a digital publication to improve access and usability. Designed to meet meaningful accessibility standards, it also includes practical features our instructors and affiliate partners rely on: internal bookmarks for navigation and hyperlinks to key policies. In a world where online resources are the standard, not the exception, this was a notable step forward.

We also turned our attention to first aid. In response to the Government of New Brunswick's adoption of CSA workplace first aid standards, the Society launched its own initiative to align our offerings. It's a significant undertaking—but one that ensures our programs remain relevant, recognized, and responsive to provincial needs.

At the national level, we contributed to major updates of the Society's Canadian Swim Patrol and Swim for Life programs. With two decades of delivery experience to draw from, it was time to reassess, refine, and improve. New Brunswick played an active role in the early stages—participating in discussions and contributing to initial data collection. The project continues in earnest and will shape the next generation of swimming instruction in Canada.

Of course, while program development is essential, we must never lose sight of why we do this work. The release of the 2024 Canadian Drowning Report was a sobering reminder that fatal drowning remains one of the leading causes of preventable death in Canada. We reflect that reality on our cover, which features a graphic interpretation of where Canadians drown (see page 10). This data grounds

us in the seriousness of our mission and motivates us to keep pushing

That motivation was clearly reflected in the continued growth of our leadership certifications—a key measure of our ability to meet the needs of New Brunswick communities. With more Lifesaving Society instructors, examiners, and trainers joining the ranks, our affiliate partners are well-positioned to meet community demand and deliver highquality programming across the province.

It was also a standout year for Lifesaving Sport. In August, New Brunswick proudly hosted the Canadian Surf Lifesaving Championships, welcoming over one hundred athletes and sixty volunteers from across Canada—including Nova Scotia, Quebec, Ontario, and British Columbia. Our sincere thanks go to our fellow branches, especially Ontario, for their support. The event's glowing reviews were a testament to the team effort behind the scenes and the dedication of everyone involved.

Finally, I express my sincere gratitude to the many people and partners who continue to make our Society's success in New Brunswick possible. To our affiliate members, instructors, and examiners – thank you for representing the Society every day in your communities. To our many valued volunteers — whether serving on councils or supporting events across the province – your time and dedication are deeply appreciated. And to my colleagues on the Board of Directors thank you for your energy, insight, and clear-eyed governance.

It's been an exceptional year. I look forward to what we'll achieve next. Sincerely,

# FINANCIAL REPORT

The summary financial information presented here is derived from the Royal Life Saving Society New Brunswick Branch Inc. audited financial statements for the year ended December 31, 2024. The Lifesaving Society New Brunswick is a provincially incorporated entity and registered charity. Detailed audited financial statements are available upon request.

The Society concluded 2024 with a surplus of \$112,000, a substantial increase over the \$19,500 surplus achieved in 2023. Total revenues climbed to \$427,000—an increase of \$105,000 (33%) over the previous year—while expenditures rose modestly by \$13,000 (4%) to \$315,000. The Society's actual surplus outpaced the budgeted projection by \$53,000, positioning the organization on strong financial footing.

This growth was led by gains across core revenue streams. Training revenues increased \$10,000 (13%) over the prior year, bolstered by fee adjustments in key programs and higher participation in National Lifequard and Bronze Medallion certifications. Literature revenue rose by \$4,300 (8%), mirroring the increase in training volumes. Leadership program revenues climbed \$5,000 (34%) as demand for instructor and trainer certifications continued to grow. Fundraising and other income categories also exceeded expectations, particularly in commissions, investment interest, and provincial grants.

On the expense side, total expenditures remained below budget by \$31,000 (9%) despite planned increases in staffing and program delivery. Salaries and benefits increased \$9,900 (5%) over 2023, reflecting a full year with the new staff structure and other anticipated salary adjustments. Member Services expenses were \$5,800 (28%) under budget, aided by cost controls in insurance, audit services, and inventory management. Meeting and travel expenditures were also lower than anticipated, helping to offset increases in operational costs.

Lifesaving Sport activity posted a minor deficit relative to budget due to the hosting of the 2024 Canadian Surf Lifesaving Championships. While revenue and expense projections were originally higher, final costs were largely borne by the Ontario branch, resulting in lower-than-expected activity in both categories.

With revenues exceeding expectations and expenditures carefully managed, the Lifesaving Society New Brunswick is well positioned to continue advancing its drowning prevention mission in the years ahead.

# TRAINING PROGRAMS

Training Programs contributes to the mission of the Society by teaching Canadians the skills and the knowledge they need to enjoy water safely and to save themselves and rescue others in an emergency. The Society's National Lifeguard certification is the standard for professional lifeguards in Canada.

2024 marked the beginning of implementing changes to our First Aid Program to comply with the new CSA Standards. As we move further into 2025, our project to be fully CSA compliant is well underway. We want to thank **Grégoire Cormier** for his leadership with this project as well as **Morgan Easton** (First Aid Chair). Your hard work is invaluable in our progress to meeting these standards.

To close out 2024 and enter 2025, we have also developed a revised and fully accessible version of our Program Guide. Our 2025 Program Guide is fully AODA compliant, meaning it is made in a higher level of accessibility to all.

At a national level, we have a Swim and Canadian Swim Patrol revision in the works. This process has begun with the consultation of our stockholders. A national survey went out to our instructors and trainers in this stream, prompting many responses from our province. This revision will continue throughout 2025.

We saw a steady increase in our Leadership programs in 2024, particularly at the Trainer level. This continues to strengthen our programs across the board. Our Lifeguard certification also saw a slight increase over the past year. This positive trend is setting us in the right direction and supporting our efforts to battle the Lifeguard shortage in the province. All other programs in Swim, Lifesaving, and First Aid, have either seen a slight decrease or have remained steady from year turnover.

# LIFESAVING SPORT

Lifesaving Sport contributes to the mission of the Society by engaging and inspiring youth in our humanitarian mission; by providing an incentive for training; by encouraging innovation in techniques, and; by providing opportunities for volunteer recruitment, retention and leadership development.

Lifesaving Sport faced another hurdle this year with the cancellation of the New Brunswick Emergency Response Championships. However, we saw development in both the Pool and the Waterfront Lifesaving Championships with growing numbers in both events.

#### 2024 New Brunswick Championships

In 2024, New Brunswick saw a notable increase in participation, with 68 athletes competing across two provincial championships.

In March, the **Canada Games Aquatic Centre** hosted the New Brunswick Pool Lifesaving Championships featuring 28 athletes from two Clubs. Later in August, the **Parlee Beach Provincial Park** in collaboration with the **Parlee Beach Lifesaving Club** hosted the New Brunswick Waterfront Lifesaving Championships. The event continued to miss the out of province athletes it historically attracted, but had three Clubs from New Brunswick and PEI competing. Congratulations to Club Champions: **Canada Games Aquatic Centre** (Pool) and **Parlee Beach Lifesaving Club** (Beach).

## 2024 Canadian Championships

In August, the Lifesaving Society New Brunswick, with the help of Ontario, Quebec and Nova Scotia branches, organized the 2024 Canadian Surf Lifesaving Championships with host **Parlee Beach Provincial Park** and the **Parlee Beach Lifesaving Club**. The event attracted 103 athletes and 60 volunteers from New Brunswick, Nova Scotia, Quebec, Ontario and British Columbia. Congratulations to **Royal City Aquatics** for the Club overall Championship.

Parlee Beach Lifesaving Club and Canada Games **Aquatic Centre** were both present at the Canadian Surf Lifesaving Championships. Parlee Beach Lifesaving Club received a gold for junior men surf swim (Keegan MacDougall), bronze for open men board rescue (Keegan MacDougall and Marcel Bourgeois) and a bronze for both the open men (Keegan MacDougall, Denny Paribok, Aaron Sellers and Marcel **Bourgeois**) and open women ocean relay (**Gabrielle** Léger, Jocelyne Melanson, Julianne Levesgue and Catherine Laplante). The Canada Games Aquatic **Centre** received gold in both the open women (**Jennifer Moore**) and open men (**Ben Tremblay**) 2 km beach run. Parlee Beach Lifesaving Club finished seventh overall and Canada Games Aquatic Centre finished ninth overall.

#### Coaches and officials

In 2024, New Brunswick saw the development of one Coach Trainer and two Official Instructors, with the goal of certifying more trainers and instructors continue developing the sport program. Additionally, 33 new officials were trained to support the continued growth of the program.

We would also like to extend our deepest thanks to the over 100 volunteers who generously donated their time to support the championships, especially our key officials: Ryan Ferguson, Mike Maguire, Doug Trentowsky, Ben Tremblay and Marcel Bourgeois.

# MEMBER SERVICES

Member Services develops and maintains the corporate functions, systems and infrastructure required to support and service the membership of the Society.

#### Governance

The National Society (Lifesaving Society Canada) is governed by a Board of Directors nominated by Branches and elected by the members at the Society's AGM. National commissions are led by volunteer commissioners. These commissions are: Public Education, Training Programs, Lifesaving Sport, Aquatic Safety Standards and International Relations. A management team is comprised of senior staff of the 10 provincial/territorial Branches.

# New Brunswick Board of Directors

A volunteer Board of Directors governs the Lifesaving Society New Brunswick in accordance with its mission and bylaws. Directors are elected for a two-year term by the Society's membership at the annual general meeting. No person or body external to the Society is entitled to appoint any directors.

At the AGM in April, the Society's Board of Directors elected President Elect Sarah-Ann Price as President and Adam Munn as the new President Elect. Joining the board were Mathieu Manuel as Corporate Secretary, Joey Doucet as Vice President Training Programs, Dave Shea as Vice President Member Services, and Gamal Ahmed as Vice President Fundraising. The Board bid adieu to David Dumont and Samantha Kuhn. Marcel McLaughlin assumed the role of Past President.

#### Activity centre councils

Activity centre councils are composed of chairs, appointed by the Board of Directors for a two-year term, who oversee specific portfolios necessary to manage the work of the activity centres. Chairs recruit and develop committee members. A vice president, or another individual appointed by the Board of Directors, chairs each activity centre council.

On the Training Programs Council, **Joey Doucet** left his role as Leadership and Bronze Chair in April in order to join the Board. **Shannon Cabel** stepped down as Swim for Life Chair in June, with **Angela Johnson** filling the position that month as well as the Leadership Chair position. **Solange Wehrmann** filled the position of Bronze Chair, also in June.

On the Lifesaving Sport Council, **Nikita Bailey** resigned as Development
Chair in June, with **Ben Tremblay**filling in the position that same
month. **Gabrielle Léger** resigned
as Athlete Representative in order to
fill the Coaches and Officials Chair
role, while **Eloise Soucy** became
the Athlete Representative. **Jacques Levesque** joined the Sport Council as
Championships Chair, also in June.

## **Annual meeting**

The Lifesaving Society New Brunswick convened its AGM on April 27, 2024, hosted by the City of Saint John at the Chateau Saint John. **Gary Sullivan**, City Councillor from Saint John welcomed participants to the City.

#### **Commonwealth Honours**

While the Society was unable to convene an Investiture ceremony in 2024, **Doug Trentowsky** was awarded the King Charles III Coronation Medal at a ceremony at Government House in October. Doug (fondly known as Mr. Lifesaving) has volunteered with the Lifesaving Society for over 40 years. From serving President of the Board to humbly timing at a lifesaving championship — he's done it all. We can't think of anyone more worthy of this recognition.
